There were so many things that went south from the beginning and nobody has ever apologized and despites all the problems they haven't changed their ways.Here are some of the topics:- In the beginning they breached the contract that was signed with them by offering a worse and different pension scheme that was agreed. It was a lower amount and they have chosen a pension provider for me even though in the contract it said that the pension will be paid out in the salary (hence in Denmark, you can choose who you want the pension to be transferred to). After a lot of fight and many hours of work I got it changed-. It takes forever to get your expenses paid out, they have to be accepted almost 1 month before the salary pay date, it's just too early and they show 0 flexibility in this- They rolled out a new work hour registration policy that is way stricter than the local law.
