Payments will be accepted at the Office of the Tax Collector, City Hall, 155 Deer Hill Avenue, Danbury, CT from 7:30 am to 6 pm, Monday through Wednesday, and from 7:30 am to money order, or certified bank check, per City of Danbury Ordinance Sec. 18-24. You may also use our drop box located to the right of the main entrance of City Hall. Please put your payment in an envelope and include your bill coupon. If you need a receipt for your payment, please include a self-addressed stamped envelope with your payment. Please note do not put cash in the drop box. In addition, property tax payments may be made at the Danbury branches of Ives Bank and Union Savings Bank, during the months of July, October, January, and April. Please note the following regarding payments at the bank branches: Only current taxes may be paid at the bank branches. Delinquent taxes may not be paid at any bank branch. You may not pay water and/or sewer taxes at the bank branches. Credit cards are not accepted at the bank branches. The City of Danbury also offers online payments via echeck or credit card. You can link directly to the payment pages for property taxes or water and/or sewer taxes at the Tax Collector homepage. Please note that our online vendor is Govolutions, and they are responsible for processing and emailing you confirmation of payments. The City of Danbury Tax Assessor's Office oversees the appraisal and assessment of property taxes, applying for a homestead exemption or other tax exemption, reporting upgrades to your home, appealing your property tax assessment, or verifying your property records. Submitting a City of Danbury property tax appeal If you believe that your house has been unfairly overappraised at a lower value by contacting the Assessor's Office to submit a property tax appeal. You will have to submit a form describing your property and sufficient proof that it is overassessed, including valuations of similar homes nearby as evidence. If your appeal is accepted, your home assessment (and property taxes) will be lowered as a result.
